



## Code of Conduct for residential visits

### Overall expectation and consequences

Students on trips represent Harrogate Grammar School. We therefore expect all students to conduct themselves **respectfully, in line with our school values**. A review of behaviour will take place two months prior to departure, and should your behaviour fall short of these standards, then you may be withdrawn from the visit. Any serious breach of our expectations after this point could also result in you being withdrawn from the trip. Any misconduct on the visit will be dealt with appropriately and may lead to possible further sanctions upon return to school. In exceptional circumstances, we may ask your parents to collect you and may not allow you to participate in further trips.

### General expectations

For the trip to be beneficial, enjoyable and safe for all, you are expected to:

- behave responsibly and show consideration for others, including fellow pupils, HGS staff, members of the public, bus drivers, and staff/instructors at our destination
- listen attentively and comply with instructions from all staff members on the trip
- respect the allocated groups for head counts and activities
- follow rules and regulations of the places we visit
- follow rules when participating in adventure activities – they are there for your safety
- in the event of an emergency, follow emergency procedure instructions
- always keep a copy and/or a photograph of the emergency card on you (if abroad)
- look after your own possessions
- wear appropriate clothing
- keep all facilities clean, tidy and undamaged – report any damage immediately
- inform staff if you have any medical conditions or injuries
- inform staff if you feel unwell
- inform staff if you have any concerns about safety or security, including inappropriate behaviour/bullying from other trip participants
- in the event of concerns/problems always share these with the trip leader/trip staff in the first instance so any issues can be quickly and directly resolved.
- do not use social media to communicate any concerns/problems. The trip leader will follow school procedure and communicate necessary information to parents in a timely manner.
- ensure that you understand any instructions when unaccompanied by staff including the meeting point and time, geographical boundaries and limitations (remote supervision)
- keep to a group of at least four during any free time (remote supervision)
- be punctual – always arrive on time and ready to go
- sensibly go to bed at the allocated time and stay in your own room until morning unless there is a problem, illness or emergency, then either find a member of staff or follow the emergency procedure – staff should not be able to hear you from the corridor

#### **On the coach**

- remain in your seat, unless given permission to do otherwise
- wear your seat belt
- use the toilet on the coach only for emergencies
- place luggage on the luggage rack or under the seat
- put litter in the bags/bins provided
- do not distract the driver – no shouting out, no flash photography etc.
- if you begin to feel travel sick inform a member of staff immediately
- when disembarking, be aware of traffic movement and direction, noting that vehicles drive on the opposite side of the road in most other countries

#### **At the airport/port and on the flight/ferry**

- always follow instructions from airport staff and security personnel including check in, security, passport control
- listen closely to instructions for a meeting place and guidance on where you can always find a teacher
- when on the flight
  - sit in your allocated seat unless given permission to move
  - pay attention during the safety briefing and follow safety instructions carefully including regarding the use of electronic devices
  - sit quietly and do not disturb other passengers around you
- when on the ferry
  - don't go on the open deck unless you are with a teacher
  - walk calmly around the ferry, no running
